

Privacy Policy - The Lone Soldier Center in Memory of Michael Levin (Registered Nonprofit Organization)

The Lone Soldier Center in Memory of Michael Levin (Registered Nonprofit Organization), 580520104 (the "**Association**") or anyone on its behalf is the developer and operator of the Association's website (the "**Site**").

The purpose of the privacy policy outlined below is to explain the association's practices regarding privacy, its website users, and how it manages information collected through the website or provided by its users. This document details the procedures the association follows in collecting and using your information ("**Privacy Policy**").

The association reserves the right to modify and update the privacy policy. You can view the most current version of the privacy policy at any time by clicking the "Privacy Policy" link on the platform's website. Significant changes will be appropriately communicated in accordance with legal requirements.

The association emphasizes its commitment to safeguarding your information and privacy. Recognizing the importance of protecting your personal data, the association takes extensive measures to ensure its security. By employing advanced, innovative methods to protect the information provided, the association continually updates and enhances these measures to uphold the highest standards of privacy and security.

The services are not available to individuals located in areas where their use is prohibited by local law.

This privacy policy, particularly in the Hebrew version, is written in masculine form but applies equally to all genders. The section titles are provided solely for ease of reading and do not influence the interpretation of these terms of use.

General

1. Lone soldiers seeking services from the association, as well as individuals interested in contributing—whether through monetary donations or other means - can reach out by submitting their details via the "Contact" tab or the registration form on the website. To do so, they will be required to provide certain personal information, including, but not limited to, their full name, email address, residential address, mobile phone number, and other relevant details ("**the information**").
2. This privacy policy applies to all information, including any personally identifiable information you provide, as well as any data collected about you during your browsing of the site.
3. The association automatically logs information received from your browser, mobile device, or other devices, including your IP address and details of the pages you visit. By accepting the site's terms of use, you consent to this data collection and logging by the association. Refer to the section below for information on the use of cookies.

Usage Information

4. The association may utilize the information collected about you for the following purposes:
 - 4.1. Contacting you, subject to the following;
 - 4.2. Conducting statistical analysis of the information for the association's purposes;
 - 4.3. Data presentation;
 - 4.4. Reviewing and enforcing the association's terms of use;
 - 4.5. Enhancing and enriching the website's content, including adding new material based on user needs;
 - 4.6. Information security and fraud monitoring: the association may use information for information security purposes as well as to prevent illegal or unauthorized use of your account or credit cards as the case may be.

By submitting your details through the "Contact Us" form, you consent to and authorize the association to use the information as described. If you do not wish for the association to utilize your information in this manner, please refrain from providing your details on the website.

5. With your explicit consent, the association may use your information for marketing purposes, including sending promotional or advertising materials via email, SMS, or other communication channels. This may also involve tailoring messages based on your location, segmentations, and preferences derived from your usage.
6. Any disputes or matters arising from or related to this privacy policy shall fall under the sole and exclusive jurisdiction of the competent court located in Tel Aviv, Israel. The applicable law governing this privacy policy shall be Israeli law.

Database

7. The information collected about you will be stored in the association's database ("Database") under its responsibility, in accordance with the Privacy Protection Law, 5771-1981 ("Privacy Protection Law").
8. The association stores information on various platforms and servers, including those utilizing cloud technology. It employs advanced information security systems and procedures on its websites to mitigate the risks of unauthorized access. However, while these measures enhance security, they do not ensure absolute protection. Consequently, the association cannot guarantee that its website will be entirely immune to unauthorized access to the stored information.
9. Every individual has the right to access the information stored about them in the database. If, upon review, a person finds that the information is incorrect, incomplete,

unclear, or outdated, they may request that the database owner correct or delete the information. Such requests should be sent to the email address admin@lsc.org.il.

10. Additionally, if the information in the association's database is used to contact you directly, you have the right, under the Privacy Protection Law, to request in writing that the information related to you be deleted from the database, unless the association is legally required to retain it.

Disclosure of your Information to Third Parties

11. The association will not sell, rent, or transfer your information, in whole or in part, to any third party without obtaining your explicit consent.
12. The association may disclose your information, in whole or in part, to third parties under the following conditions:
 - 12.1. The transfer of information as required by law, including to affiliated parties providing services for the association.
 - 12.2. The association may disclose the information if required by law or as necessary for legal proceedings.
 - 12.3. The disclosure of information, in whole or in part, to specific parties is necessary for purposes such as information security, including verifying your identity. It is important to note that, unless otherwise stated, these parties are not authorized to use this information for any purpose beyond that for which it was provided by the association.
 - 12.4. The association may disclose your information if it determines that your actions on the site violate the terms of use or are intended to commit any form of fraud.

Links to External Websites

13. Some services may include links (hyperlinks) to external websites, including those provided by entities advertising through the services. These links are offered solely for your convenience. Use of information or content on the linked external sites requires careful consideration and discretion. It is important to note that the association has no control over, nor responsibility for, the content found on these external websites.
14. The links provided in the services should not be interpreted as a recommendation, endorsement, or approval of the materials, content, or products available on external websites. Additionally, these links should not be seen as a guarantee of the reliability, accuracy, or completeness of the information they contain. The association assumes no responsibility for any reliance on or actions taken based on the content of such external websites.
15. The association may utilize third-party software or services, both in Israel and abroad, to collect, store, and/or process information gathered through the site.

Cookies

16. A "cookie" is a small text file sent to your device by a web server. It is not a computer program and cannot read or interact with the information stored on your device. Cookies are used to enable the association's servers to recognize you quickly and efficiently when you return to the site or visit other related sites.
17. By accepting these terms of use (and unless you modify your browser settings to block them), you consent to the association placing a cookie on your device, using the information stored within it, and identifying you through it.
18. The association may use cookies to display its advertisements on various websites you visit ("third-party providers"). While browsing these websites, information about you may be collected and used by the association to tailor advertising content to your interests without specifically identifying you.
19. The association is not responsible for the operation of third-party provider websites or the content they offer, as these are entirely independent sites. It is recommended to review the privacy policies of each third-party provider's website.
20. If you prefer to block cookies while browsing a website, you can adjust your browser settings to prompt for your permission each time or to block cookies entirely. If you're unsure how to do this, consult the help section of your browser for guidance. Please note that disabling cookies may impact the functionality of certain services and limit the ability to store information about your preferences and browsing habits.
